- Packages are sold on a strictly “first come first serve” basis and sites will be allocated on the same basis.
- A 50% deposit is due on submission of booking sheet.
- Balance of site due 1st March, 2012.
- **OCCUPANCY OF YOUR SITE WILL NOT BE ALLOWED UNLESS FULL PAYMENT FOR YOUR SITE HAS BEEN RECEIVED BEFORE THE EVENT.**
- All cheques to be made payable to Invent Hospitality (Pty) Ltd, First National Bank, Claremont Branch, Branch Code 200 109, Account No 620 545 73285.
- Any cancellations will incur a cancellation fee:
 - ❖ 50% - if cancelled more than 2 months prior to the event day
 - ❖ 75% - if cancelled more than 14 days prior to the event day
 - ❖ 100% - if cancelled less than 14 days prior to the event day.
- **NO** open fires are allowed in the Hospitality Village Area.
- **NO** Advertising or distribution of samples will be allowed at the event other than site branding within the designated area.
- **NO** helium balloons are allowed. The airspace above the Hospitality Village area is restricted for emergency services.
- **NO** marquees or structures are allowed unless sourced through Invent Hospitality.
- **NO** structures larger than 3m x 3m are allowed on any site.
- Clients will be held liable should there be any shortages or damage done to their marquee, Bedouin, gazebo or infrastructure.
- **In accordance with the Safety at sports and Recreational Events Bill, Clients are strictly advised to adhere to the following:**
 - ❖ **NO** Alcohol may be brought into the Corporate Hospitality Village Area
 - ❖ Alcohol may **only** be consumed within your designated Hospitality Area. **Any alcohol found outside the designated hospitality site will be confiscated.**
 - ❖ Alcohol ordered may **not** be sold to third parties or consumed by minors
 - ❖ **NO** smoking in any enclosed areas.
